Devoting her nearly 30-year legal career assisting clients with domestic relations matters, Nancy's legal experience also includes work with clients in business, real estate, guardianship, and trust and estate matters. Nancy works with her clients in a multitude of out-of-court settings - as their collaborative law attorney, as a neutral mediator in pro se and attorney-assisted mediations, and as a conflict coach. She committed her practice to out-of-court settlement processes in January 2015 and no longer litigates disputes.

Parallel to her private law practice, Nancy has been a non-profit consultant since 1993, and has served in volunteer leadership roles in nearly two dozen non-profit organizations. She has consulted with numerous boards through growth and change processes, focusing on leadership, strategic planning, operational and policy oversight, team development (board, staff, volunteers), strategic facilitation, and capital improvement campaigns. Her involvement in non-profits runs the gamut from social services, education, politics, public safety, and the arts.

She was graduated from University of Oregon School of Law (1991), and has a BA in Communications from University of Portland (1986). Nancy holds a license to practice law in Washington (1991) and Oregon (1992).

In 2014, Nancy co-founded a non-profit educational organization, Two Rivers Institute for Dispute Resolution, where she teaches peacemaking strategies to conflict professionals and leads a practice group of collaborative professionals (lawyers, mental health practitioners, and financial planners), all of whom devote their practices to non-court resolution of interpersonal disputes.
